Anti-social behaviour occurring in this area the Police are aware and will patrol the area.

Burglary intervention is taking place if residents would like advice please contact the SNT team direct. PC Matthews stated it is not illegal to park on a pavement unless it causes an impassable obstruction, if Police attendance is required the caller will need to wait until the Police arrives this is because if the pedestrian leaves it is no longer an obstruction and there is nothing to investigate.

PC Matthews was informed that the Community centre has bouts of anti-social behaviour in the car park this has been added to the Police patrols.

Clerk received notification of a petition from residents regarding a request for additional parking provision for the residents of North Close. Cllr Dale stated that he had emailed the petitioner on this matter and parking would be improved if the top of the road was closed off. District Council spends around £280K per year on parking provision for Council owned properties like Apperknowle. Cllr Dale offered to meet with residents. The main issue is that there is hardly any grassy areas to turn into parking in that area,

17/23 Grant approval for new fencing around play equipment at Sharman Park, Apperknowle

Clerk reported that the grant application for replacement fencing had been approved and the contractor will be starting works soon.

18/23 Caretaker/Warden's Report

- 1. The boiler at the Community hall is currently under repair (heat exchanger). The heat exchanger is covered on the plan the Council currently operate. However, there is a need for a filter system and this is not within the plan. Some hirers are still using the hall but one or two have cancelled until it has been fixed.
- 2. Chubb Fire have replaced the batteries in the fire alarm system in the Community Hall.
- 3. Chubb Fire have also tested all the fire extinguishers with no issues to report
- 4. The hall needs a replacement kitchen rubbish bin Caretaker will look at a replacement
- 5. All the batteries in the defibrillator have been replaced
- 6. Routine checks on all bins, dog bins, grit bins, bus stops and benches around the parish.
- 7. The new grit bin for Hundall was installed on Windmill Lane/The Common by DCC in December.
- 8. The dog bin at St John's play area was relocated in December by NEDDC.
- 9. Routine checks and litter picking on all play areas.
- 10. Quite a number of fly tipping incidents were reported before Christmas around West Handley mainly.
- 11. Winter/spring plants were planted at Apperknowle and at the Community Hall in December.

- 12. Servicing has been scheduled for the mowers which will be in the next few weeks ready for the new season.
- 13. A tree has fallen in the wind on Unstone Green. This should be removed this week it did have a fungus growing in it. There may be issues with a couple of nearby trees that the Clerk has asked for further advice on. They are leaning quite considerably.
- 14. At the end of November, the play equipment and the bench at Brierley play area was vandalised with offensive graffiti. The caretaker has managed to remove this, but it left a slight residue. The police were informed but have not heard anything more on this matter.
- 15. The CCTV mast is in place at Brierley play area awaiting ASI security to install new cameras.
- 16. Lease van was returned in December but the new vehicle is not ready yet. There were a few scratches on the lease van which the Council will need to pay for amounting to £12.00
- 17. The new flagpole is almost completed at the Community Hall. The concrete base has been laid. **RESOLVED** Noted

RESOLVED strongly object against this planning application due to the development being based on greenbelt land. The Council feel that the demand for this type of housing has been met with the construction of the housing at the boat yard site (previous studies carried out). The speed of the road is also an issue due to recent speed watch studies that have taken place, most drivers are over the current 30mph limit, the visibility coming from and into the site would be an issue due to the road curve and also the drop off and pick for the school this would cause significant concerns for children's safety.

The housing development drawings that have been submitted are not attractive.

The Council have also received objections from residents regarding the movement of the bus shelter to another location on the same main road through Unstone this would mean a further distance to be travelled by residents to get to the bus stop and also where the bus stop could be located it maybe more dangerous in residents getting to it especially with the new cycle path which is being constructed through Unstone.
